**SAFETY
FIRST**

Marshalling

Area will be for designated personnel only. Only those who attend the safety briefing meeting will be allowed inside the marshalling area. It is expected that all competitors, stewards, judges, pole pullers, and officials attend the safety briefing.

Competitors:

All competitors will be required to operate their or any machinery, equipment within the manufacturer's specifications, and in a safe and capable manner to comply with NZ HSWA 2015.

RULES OF DAYS EVENTS, BUT NOT LIMITED TO:

1. Be aware and consider the safety of others, ensure the covering of sharp edges, lay coulters down flat, also lay flat, additional wheels and strikeout poles.
2. Tractors – drive slowly all together when in a parade formation through the crowds, ensure travel speed is approximately walking pace, with a distance of approximately 5 metres between vehicles / machines.
3. Have poles and or tools secured adequately to tractor or plough when parading to and from plots.
4. Passengers on plant, machines or equipment is not permitted.
5. Do not mount/dismount from a moving tractor/machine.
6. Use 3 points of contact, facing the tractor, when entering and exiting tractor, machine or equipment, and all plant is to be stationary.
7. Ensure that no-one of underage drives/operates any vehicle or machine.
8. All drivers must be seated on their tractor to start the engine, (if electric start)
9. All drivers must not be operating machinery under the influence of drugs or alcohol.
10. Ploughs must be lowered when not in use.
11. Safety stands for ploughs must be used at all times during underside adjustments and be of sufficient strength to hold the weight of the plough.

Personal Safety:

Please ensure that you keep yourself and any one in the care of you hydrated, use sunscreen, hearing protection if required. If needed, see a steward for any first aid, or first aid equipment needed. Keep any loose-fitting clothing away from levers, drive and tail shafts or any unshielded moving parts etc. Wear good fitting closed in boots at all times. No smoking on the grounds, (this is to reduce the risk of fire in stubble.)

Vintage:

All trailing ploughs need to have a lock on the trip lever and must be used when making underside adjustments.

Horses:

Ensure that there is no riding on ploughs unless there is a seat provided. No standing on ploughs. Horses are to be led through crowds.

Public:

A: All public are requested to keep well clear of moving machinery at all times.

B: All public must remain behind fences and roped off areas.

C: All NZPA officials are safety officers, empowered to enforce safety standards

D: Instructions from officials must be obeyed at all times.

Environmental:

A: Any HSNO spills (Fuel, oils, coolant etc) must be contained as soon as possible to keep soil contamination to a minimum, also notify a NZPA official as soon as practicable so a clean-up plan can be implemented. (A spill kit is kept in the NZPA plough box)

B: Maintain compliance with all applicable environmental laws and regulations, including the Resource Management Act 1992.

C: Ensure all equipment is clean before transporting to event site, as not to import any contaminated soil to farm site.

D: Ensure all equipment is clean before transporting off event site.

E: Any refuelling of plant and equipment must be performed in a refuelling area designated by an onsite NZPA official.

GENERAL:

If you need help, advise a steward or an official. They will pass on your message to Head Stewards in the NZPA tent and they will notify the appropriate people and record any issues or incidents in a site safety register.

Any safety concerns at all, contact a Head Steward or any NZPA official

The NZPA safety policy must be sighted with this form.

**SAFETY
FIRST**

You are entering a multi hazard area with working vehicles, tractors and or machinery.

Follow instructions of officials at all times.

Please observe the following rules:

1. Safety is everyone's responsibility.
2. Safety must be an integral part of the day's activity, A responsible attitude to safety by all on site is vital to the success of this event.
3. All children under 16 must be under the supervision of an adult.
4. All personnel / must stay behind the safety roped off event area, except persons taking part in the event at that time.
5. Keep a safe distance from all machinery (moving or stationary)
6. In the event of an accident or incident notify a Head Steward or an official at the NZPA tent as soon as practicable.
7. In case of an emergency - the assembly point is adjacent to the NZPA tent.
8. Please be aware of barbed wire, electric fences, water areas and open ditches, we ask that you do not climb over or through these.
9. Be aware, this is a working farm, we ask that you do not venture past the boundary's of this event without further induction of the property's H&S policy and rules.
10. If you, for any reason, feel unsafe at this event, you are welcome to leave at your convenience in a safe manner.
11. If you see an unsafe act, or item, please stop all movements around affected area and contact an NZPA official or Steward immediately.
12. Any HSNO spills (Fuel, oils, coolant etc) must be contained as soon as possible to keep soil contamination to a minimum, also notify a NZPA official as soon as practicable so a clean up plan can be implemented.

- Have the confidence of the NZPA to act on their behalf if required

The New Zealand Ploughing Association Executive, following consultation with the New Zealand competitors will appoint the above positions. The NZPA Executive, after considering the applications and recommendations may consider combining some roles.

If combining roles, applicants will receive the highest valued funding to which they are appointed. Travel reimbursement as per NZPA policy

All applicants must clearly identify which position the applicant is applying for.

Manager

The role of Team Manager is to support and take the pressure off the competitors so they can concentrate on competing. While away, the Team Manager is the voice of the team and the window to what is going on for those back in New Zealand. Regular reports and photos are essential to keep our sponsors and supporters involved. Reports can be delegated to others and must be forwarded to the NZPA Executive for approval before being made public.

In consultation with the team and World Board Member:

- Ensure that the team and their partners are registered with the host country and have pre event accommodation and vehicle
- Liaise with the team for pre- practice ground
- Manage clothing/uniforms
- Co-ordinate travel arrival dates and times with the rest of the team and the Executive

Remain with the competitors onsite for the amount of time agreed between the contestants/Manager and the NZPA Executive

Send regular photos and reports back to NZ for approval and distribution to NZPA members, sponsors, Facebook and website. (Reports must focus on the positives).

Send results back to NZ for distribution

Write a report to the NZPA after the event

Provide NZPA with a balance sheet of expenses, after the event
